

Councillor Privacy Notice

Reviewed and Agreed by LPC Meeting 17 July 2023 (with amendments)

When you sign your acceptance of Office and take your seat on the Loose Parish Council (LPC), the information you provide (name, address, email address, phone number, declaration of personal Interest (DPI), and other relevant information) will be processed and stored. This is so that you can be contacted, and so that the LPC can retain this information during your time in Office. The Council will provide you with a dedicated email address for use of LPC business. Your personal information will not be shared with any third party other than those related to a statutory or lawful requirement, such as publication of your DPI, or anything other with your consent.

When you contact us

The information you provide (personal information such as name, address, email address, phone number, etc) will be processed and stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will be not shared or provided to any other third party.

The Councils Right to Process Information

General Data Protection Regulations Article 6 (1) (a) (b) and (e)

Processing is with consent of the data subject or

Processing is necessary for compliance with a legal obligation or

Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

Information Security

Loose Parish Council has a duty to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and appropriate policies. Copies of these policies can be requested.

We will only keep your data for the purpose it was collected for and only for as long as is necessary. After which it will be deleted. You may request the deletion of your data held by Loose Parish Council at any time.

Access to Information

You have the right to request access to the information we have on you. You can do this by contacting the Clerk.

Information Correction

If you believe that the information we have about you is incorrect, you may contact us so that we can update it and keep your data accurate. Please contact the Clerk, to request this.

Information Deletion

If you wish Loose Parish Council to delete the information about you, please contact the Clerk, to request this.

Right to Object

If you believe that your data is not being processed for the purpose it has been collected for, you may object. Please contact the Clerk, to object.

Rights Related to Automated Decision Making and Profiling

Loose Parish Council does not use any form of automated decision making or the profiling of individual personal data.

Complaints
