

MINUTES OF THE EXTRAORDINARY PAVILION & COMMUNITY HUB (PCH) COMMITTEE MEETING

Tuesday 20 May 2025 at 7.30pm

in the Loose Parish Pavilion, King George V Playing Field, ME15 9RG.

Councillors taking part: Vianne Gibbons (Chair-VG), Velma Bennett (VB), Neil Lettington (NL). **Also present**: Nicky Bourne (Clerk - NB) and Amanda Baker (Assistant Clerk - AB) who took the minutes. A proposal from Loose Football Club for a ten-year lease agreement had been pre-circulated and was discussed at length. This included facilities, usage times, maintenance, parking, storage, insurance, management and review, termination clause and charges. The existing groundswork contractor will be consulted on a number of maintenance matters and responses will be circulated to all parties. Action: NB. The Committee **AGREED** that LFC would be charged the sum of £1200 per annum, payable on 1 June each year, for the use of the pitches on King George V Recreation Ground and the facilities in the Loose Pavilion. The charge will be reviewed annually and only varied with the written agreement of both parties. The Committee **AGREED** a long-term hire agreement document should be drafted and circulated for agreement by ROUND ROBIN. Action: NB/AB.
