7. 25/502815/FULL New Line Learning Academy Boughton Lane Maidstone Kent ME15 9QL

Creation of a new halls and music block for New Line Learning Academy and Tiger Primary School, with associated support spaces and works to external landscape to accommodate. No change of use is proposed.

Whilst the Planning Committee **AGREED** that they had no objection to this application they do wish to make the following points:

The Committee would like to see a planning condition put in place to monitor the
noise. There is a noise impact assessment setting the base line, within which there
are several mistakes. It talks about farmland to the West of the site, it is in fact to
the East of the site. The location given as a monitoring point is 12 Boughton Lane, in

- their opinion this should be 12 Leigh Avenue. They would like to see a more detailed noise assessment during construction and going forward.
- The Committee requested that a Construction Plan should be a planning condition, covering noise levels, hours of working, parking for workers and the movement of construction traffic at dropping off and picking up times.
- The Committee is disappointed that there is only four lines on sustainable travel in the transport assessment.

Vehicle backing up is witnessed on Boughton Lane, especially where vehicles are seeking to turn across the traffic. A particular pinch point is the Boughton Lane / Paynes Lane junction near the site entrance. The narrow (one car width) Paynes Lane is used as a cut-through by cars, vans and minibuses who compete for space with pedestrians since the lane has no pavement. This 'competing for space' can lead to vehicles reversing from the junction back into the traffic flow on Boughton Lane. It states that there the footways are suitable for walking. To the north there is a very narrow path on Boughton Lane and no footpath on Paynes Lane. To the South there is no footway, with Ancient Woodland on one side and people's gardens on the other.

The Planning Committee would like to see an improvement to the footways.

8. 25/502867/FULL 44 Lancet Lane Maidstone Kent ME15 9SA

Erection of single storey side and rear extensions and alterations. Removal of existing side extension.

The Planning Committee **AGREED** that they had no objection to this application.

Lawful Development Certificate for proposed erection of a single storey rear extension. The Planning Committee **AGREED** that they had no objection to this application.
